Re: NOTICE TO CEASE AND DESIST INTERNET DEFAMATION AGAINST MINA MAR GROUP INC. AND MIRO ZECEVIC

Dear Mr. Van Rainey:

Please be advised that our law firm has been retained by Mina Mar Group Inc. and Miro Zecevic to take possible legal action against you in Canada for the series of defamatory attacks made by you against them on the web site "Investorshub.com" and their affiliated web sites.

As you may be aware, Mina Mar and Miro Zecevic have already commenced legal proceedings against Investorshub and their principals and at this time they are considering expanding that litigation to include individual posters on the InvestorsHub web site who have engaged in defamatory conduct against them.

You have personally posted many willfully false and misleading comments about our clients. Some examples of your defamatory statements include:

1. "this is a Minamar scam being operated out of toronto canada by criminals Miroslav zecevic, Andrea zecevic and garr winters. this is undeniable"
2. "andrea isnt a scientist. Miroslav uses her (his wife) to spread BS lies. one minute she is a scientist, the next she is mining engineer in peru when in reality is a criminal co conspirator"
3. "its all the same thing. its all connected to the criminal stock fraud ring being operated out of toronto canada by minamar and zecevic"

4. “this is a proven criminal operation being run by a career conman miroslav zecevic”
5. “HTDS is about to get halted. the recent submission to pinksheets is full of lies, false statements and shows a history of criminal activity by zecevic and minamar. I will in following posts go through each item that will be sent to the sec, FINRA and pinksheets on monday.”

Additionally, your comments and posts actively encourage and solicit defamatory statements from other users of InvestorsHub. You could have serious financial exposure to Mina Mar and Miro Zecevic for each and every single defamatory statement.

Your conduct of spreading libelous and defamatory statements and comments about our client have caused them serious and irreparable injury to its business and its reputation within the investment community.

While you certainly have a right to express your opinions, you do not have the right to make false statements of fact injurious to another’s reputation. The comments posted by you on InvestorsHub.com go far beyond the mere expression of opinion. They are false statements of facts that have damaged our clients business and reputation.

THEREFORE, we hereby demand that you:

1. Immediately **CEASE AND DESIST** from making defamatory comments against our clients on any and all web sites, including, but not limited to InvestorsHub.com
2. Immediately delete or remove from InvestorsHub.com, and any other web site, all defamatory and disparaging remarks made by you against our clients.
3. Issue a letter of apology in writing to our client for the damages that your actions have brought upon them.

If you refuse to comply with our demands within 1 week of receipt of this letter, Mina Mar and Miro Zecevic will have no choice but to pursue all legal claims against you, including the filing of a lawsuit. In that lawsuit, they will pursue not only damages caused by your actions, but attorney’s fees and court costs.

YOU DO NOT HAVE PERMISSION TO PUBLISH THIS LETTER ONLINE OR IN ANY OTHER FORM OF MEDIA.
